ADDITIONAL CLAUSES

1. The terms are inclusive of all expenses for see special clauses overleaf
2. It is agreed that the artiste will appear in person throughout the performance of his Orchestra/Band/Act.
3. Playing times to be decided by the Management but it is agreed that the artiste will not be required to play more than a total of one hours in 1 x 60' sessions. Artistes to arrive no later than t.b.a. Equipment no later than t.b.a.
4. All financial settlement to take place with see attached rider clauses
5. It is a condition of this engagement that both Musician and the Director are members of the Musicians Union. In no circumstances shall the Musician be called upon to play with or in the same establishment as other Musicians who are not members of the Musicians Union.
6. The Artiste shall not, without the written consent of the Management, appear at any public place of entertainment within a radius of xxxxxxxx miles of the venue during a period of xxxxxx weeks prior to and xxxxxx weeks immediately following the engagement.
7. The Artist(s) agree that if they are re-engaged at the above stated venue, within twelve months from the date of the above engagement, they will be re-booked by Astra International Entertainments Ltd.

1. A deposit of Fl. 650,- is payable by certified cheque or accepted bank draft or cash to Cyril J. Van Den Hemel, Potgieterstraat II Haarlem holland together with a signed contract no later than Four weeks proir to the engagement

The balance to be paid in cash on the day of the performance to the Artiste or his authorised representative, prior to the commencement of the concert set forth herein.

The fee is to be nett and free of all local taxes and other incumberances.

Management to secure hotelaccomodation on the night of the engagement for nine persons. Payment of the accomodation is the responsibility of the management

Management to be responsible for the safety and protection of the Artiste and his equipment. Management will therefore indemnify the Artiste against any loss or injury due to lack of protection facilities.

Management to be responsible for obtaining all permits that are required to fulfil this engagement. Failure to provide such shall in no way prejudice the Artiste"s salary, which is to be paid in full.

Management to provide fist class dressing room facilities for nine persons with lock and key and equipped with cold and hot running water.

Management agrees that the back stage area will be kept clean of all unauthorised persons, unless Artiste have given their written authority.

Management agrees to supply a stage with the following sizes :
Stage area 25ft. deep by 30 ft. wide and to be a minimum of 4 ft. from the ground. On each side of the stage must be an area of 5ft. deep by 8 ft. wide by 4ft high. (This makes a total of front stage width of 46ft.)

Management undertakes to provide the Artiste with a list of details, such as addresses of venue and hotel, appropriate arrival times for equipment and group, performing times, no later than three weeks prior to the engagement.

Management agrees to supply two crates of Heineken beer on the day of the performance.

Management to supply a Piano tuned to A440 Hz. pitch (concertpitch).

ALL OF THE PROVISIONS OF THIS CONTRACT AND RIDER ARE OF THE ESSENCE AND THE FAILURE OF THE MANAGEMENT TO COMPLY WITH ANY OF THEM SHALL CONSTITUTE A BREACH.
